M&G Model Maintenance Proposals - Motion: Cindi Collins motioned and Rivka Jomsky seconded to approve the 2 proposals from M&G Maintenance 1) To begin monthly service in November, 2016 at \$39.00 per visit (1 time per week during Nov, Dec Jan, Feb, Mar & Apr, and 2 times per week during May, Jun, Jul, Aug, Sep & Oct). 2) To do a deep cleaning for the one time amount of \$125.00. The Board asked management to contact Elite and cancel their services and give them payment for 2 weeks' notice. Motion passed unanimously.

Correspondence – A homeowner sent a letter to the Board requesting a 2nd key to the pool. The Board stated this was against the Association's Rules and Regulations and asked management to send a letter to the homeowner informing them that each home is only allowed one pool key.

Adjournment - There being no further business, the meeting was adjourned at 8:00 p.m.
