Landscape

Mr. Annino advised Ms. Minnis that he will stay on top of all the landscape activity and stay in touch with Ms. Minnis to have open communication regarding any landscape problems. MOTION: A motion was made by Rivka Jomsky to approve the proposal presented by Valley Crest Landscape regarding to remove and grind stumps between 5739 – 5761 Calle Pamaro and 248 Camino El Rincon in the amount of \$1,725.00. Motion was seconded by Judi Balisciano and passed unanimously.

MOTION: A motion was made by Rivka Jomsky to approve the proposal presented by Valley Crest Landscape regarding 291 El Rincon in the amount of \$155.02 with a color picture and description of what will be planted included in the amount up to \$200.00. Motion was seconded by Judi Balisciano and passed unanimously.
